## **Rector's Decision No. 9/2025**

on the determination of tuition fees, fees associated with studies  
and reimbursement of costs associated with increasing  
qualifications in the 2025/2026 academic year at UPJŠ in Košice

Under the provisions of Section 92 of Act No. 131/2002 on Higher Education Institutions and on Amendments and Supplementation to Certain Acts, as amended (the "Higher Education Act"), in accordance with the provisions of Article 4(3) of the Organizational Rules of the Pavol Jozef Šafárik University in Košice, as amended, and in accordance with the calculation basis for determining tuition fees and fees associated with studies at a public higher education institution, approved by the Ministry of Education, Science, Research and Sport of the Slovak Republic,

### **I issue**

the following Rector's Decision No. 9/2025 on the determination of tuition fees, fees associated with studies and on the reimbursement of costs associated with increasing qualifications in the 2025/2026 academic year at UPJŠ in Košice (hereinafter the "Decision" or "Fees Rules").

### **Recitals**

1. This decision governs the determination of tuition fees for students admitted and enrolled in studies in the 2025/2026 academic year.
2. Tuition fees for students continuing their studies in the 2025/2026 academic year are governed by the rules in force at the time of their enrolment. Tuition fees under Article 1(1) of the Fees Rules are governed by this regulation regardless of the student's enrolment in study.
3. In accordance with these rules, the faculties of UPJŠ in Košice and the Institute of Physical Education and Sport of UPJŠ in Košice are entitled to request tuition fees and fees associated with studying at UPJŠ in Košice from students in the 2025/2026 academic year as follows:

### Art. 1

#### Tuition fees of the 1<sup>st</sup> to 3<sup>rd</sup> degree programmes of higher education

1. **The tuition fee for studies longer than the standard length of study of the relevant programme shall be determined as a proportional part of the annual tuition fee or of the tuition fee per academic year for the study of the programme according to the table below, depending on the number of credits to be obtained by the student in the relevant academic year in relation to the student's standard workload, in accordance with the provisions of Section 92(6) of the Higher Education Act.**

2. If a student is simultaneously enrolled in several programmes in one academic year, only one year is counted towards the total period of study.

**Art. 6**  
**Common provisions**

1. The basis for determining tuition fees and fees associated with studies according to the provisions of Section 92(1) of the Higher Education Act for the 2025/2026 academic year is €740.
2. Under Article 1(1) and (3) (a) and (b) of these Fee Rules, the Rector may reduce, waive or postpone the due dates on the basis of a student's written request, taking into account the student's study results, social and health situation or other facts worthy of specific consideration. The student must submit a written request to the Study Department of the relevant faculty, but no later than 8 days from the date of delivery of the decision on the assessment of tuition and fees.
3. Fees under Article 1(3)(d) and Articles 2(1) to 6 of these Fee Rules may be reduced or waived by the Rector for employees or employees' children.
4. The form of payment and the due date of fees are set out in the Statute of UPJŠ in Košice, as amended.
5. The conditions for waiving, reducing or allowing the postponement of tuition fees are set out in Article 47 of the UPJŠ Statute, which sets out the conditions for waivers, reduction or permission to postpone the payment of tuition fees and fees associated with study.

#### **Art. 7 Final provisions**

1. The fees rules were discussed at the meeting of the Academic Senate of UPJŠ in Košice on 23.01.2025.
2. These Fees Rules enter into force on the day of their signature by the Rector and become effective on 1 September 2025.
