Amendment No. 1 to Rector's Decision No. 4/2021 on determining the content of the inaugural file at Pavol Jozef Šafárik University in Košice and its parts

Pursuant to the provisions of Section 76 of Act No. 131/2002 Coll. on Higher Education Institutions and on Amendments to Certain Acts, as amended (hereinafter the "HEI Act"); according to the provisions of Section 23 of Act No. 269/2018 Coll. on Quality Assurance in Higher Education and on Amendments to Act No. 343/2015 Coll. on Public Procurement and on Amendments to Certain Acts, as amended (hereinafter the "Higher Education Quality Assurance Act"); Decree of the Ministry of Education of the Slovak Republic No. 246/2019 Coll. on the procedure for obtaining the scientific-pedagogical titles and the artistic-pedagogical titles of associate professor and professor, as amended (hereinafter the "Decree"), and in accordance with the Standards for Habilitation Proceedings and Inauguration Proceedings of the Slovak Accreditation Agency for Higher Education of 1 November 2024 (hereinafter the "Standards"), and Rector's Decision No. 20/2025, regulating the procedure for obtaining the scientific-pedagogical titles and artistic-pedagogical titles of associate professor and professor at Pavol Jozef Šafárik University in Košice, ref.: REK00002/2025-UPA/1922, and Rector's Decision No. 21/2025, determining the criteria for obtaining the scientific-pedagogical titles and the artistic-pedagogical titles of associate professor and professor at Pavol Jozef Šafárik University in Košice, ref.: REK00002/2025-UPA/1943,

I hereby issue

the following Amendment No. 1 to Rector's Decision No. 4/2021 on determining the content of the inaugural file at Pavol Jozef Šafárik University in Košice and its parts (hereinafter "Rector's Decision No. 4/2021").

Article I Subject of the Amendment

Rector's Decision No. 4/2021 is hereby amended as follows:

- **Text in the header reads:**

Pursuant to the provisions of Section 76 of Act No. 131/2002 Coll. on Higher Education Institutions and on Amendments to Certain Acts, as amended (hereinafter the "HEI Act"); according to the provisions of Section 23 of Act No. 269/2018 Coll. on Quality Assurance in Higher Education and on Amendments to Act No. 343/2015 Coll. on Public Procurement and on Amendments to Certain Acts, as amended (hereinafter the "Higher Education Quality Assurance Act"); Decree of the Ministry of Education of the Slovak Republic No. 246/2019 Coll. on the procedure for obtaining the scientific-pedagogical titles and the artistic-pedagogical titles of associate professor and professor, as amended (hereinafter the "Decree"), and in accordance with the Standards for Habilitation Proceedings and Inauguration Proceedings of the Slovak Accreditation Agency for Higher Education of 1 November 2024 (hereinafter the "Standards"), and Rector's Decision No. 20/2025, regulating the procedure for obtaining the scientific-pedagogical titles and the artistic-

pedagogical titles of associate professor and professor at Pavol Jozef Šafárik University in Košice, ref.: REK00002/2025-UPA/1922, and Rector's Decision No. 21/2025, determining the criteria for obtaining the scientific-pedagogical titles and the artistic-pedagogical titles of associate professor and professor at Pavol Jozef Šafárik University in Košice, ref.: REK00002/2025-UPA/1943,

I hereby issue

the following Amendment on determining the content of the inaugural file at Pavol Jozef Šafárik University in Košice ("UPJŠ") and its parts.

- **Article 2 paragraph 1 reads:**

1. After completing the parts of the inaugural file specified in Article 1, paragraphs 1–15 and 17–20 of this Decision, the dean of the faculty shall ensure that the inaugural file is submitted to the Rector of Pavol Jozef Šafárik University in Košice for preliminary review, prior to the appointment of the inauguration committee and opponents in accordance with Part III, paragraph 6 of Rector's Decision No. 20/2025, regulating the procedure for obtaining the scientific-pedagogical titles and artistic-pedagogical titles of associate professor and professor at Pavol Jozef Šafárik University in Košice.
- **Annex 2** – An overview of the minimum threshold values of measurable indicators as one part of the documentation for the evaluation of the fulfilment of the requirements for obtaining the scientific-pedagogical title of professor in the field of habilitation proceedings and proceedings for the appointment of professors **is replaced by** Annex 2/A - An overview of the minimum threshold values of measurable indicators as one part of the documentation for the evaluation of the fulfilment of the requirements for obtaining the scientific-pedagogical title of professor in the field of habilitation proceeding and proceeding for the appointment of professors, which becomes an integral part of this Rector's Decision No. 4/2021.

 - Throughout the text of Rector's Decision No. 4/2021, "Annex 3" in all grammatical forms **is replaced by** "Annex 3/A" in the appropriate grammatical form.

Article II Final provisions

1. Other provisions of Rector's Decision No. 4/2021 remain unaffected by this Amendment and remain in force.
2. This Amendment comes into force and effect on the day of its signing by the Rector of UPJŠ.

Purpose of personal data processing: inauguration proceedings

Legal basis for the processing of personal data: consent of the data subject

Personal data is processed only by properly instructed authorized persons.

Recipients of personal data: Ministry of Education, Research, Development, and Youth of the Slovak Republic, UPJŠ website.

The Controller does not intent to transfer the processed personal data to a third country or international organization.

Retention period: UPJŠ archives and retains personal data within the period stipulated by applicable legal regulations and the UPJŠ Records Retention Policy and the Records Retention Plan.

There is no automated decision-making at UPJŠ, including profiling, referred to in Article 22(1) to (4) of GDPR.

The data subject has the right, upon written request:

- a) to request access to their personal data from the Controller;
- b) to request the rectification, erasure or limitation of the processing of their personal data from the Controller;
- c) to object to the processing of personal data;
- d) to the portability of their personal data;
- e) to withdraw their consent to the processing of personal data at any time if the personal data is processed on that legal basis;
- f) to lodge a complaint to the supervisory authority, i.e. Office for Personal Data Protection of the Slovak Republic.

The rights of the data subject are further specified in Articles 15 to 21 of GDPR.
