Erasmus is a mobility program of the European Union that allows you to travel abroad (EU countries + North Macedonia, Serbia, Iceland, Liechtenstein, Norway, Turkey) with financial support.

mobility = study stay or traineeship abroad

study stay/study = part of your studies that you complete at a partner university abroad

traineeship = practical experience abroad during which you get to try working in your field of study

LA/OLA = (Online) Learning Agreement; a contract specifying the content of your mobility

financial contract = an agreement between you and UPJŠ based on which you will receive the financial support

students with fewer opportunities = the participants can receive additional financial support; more info available here:

Coordinator at Faculty, Institute, or Department

- helps you with the content of the LA/OLA
- approves the selection of courses
- **specifies the deadlines and conditions of the application procedures**
- assists with course recognition

International Relations and Internationalisation Office

- handles administration (receives the LA/OLA)

You can spend **12 months per a study cycle** on mobilities (24 months in case of long cycle studies).

All types of physical mobilities, including graduate traineeships, count towards the total number of months.

Study Administration Office

- receives documents for course recognition
- enters grades into AiS



STUDY



Take part in a study mobility at a partner university abroad.

You can only participate in studies at universities with which UPJŠ has a valid inter-institutional agreement. The list of currently valid agreements and their conditions is regularly updated by the Department of International Relations and Internationalization.

LONG-TERM MOBILITY

Who can participate in mobility?

All duly enrolled full-time and part-time students from their 1st year of study can participate.

When will the mobility take place?

The mobility will take place in the second semester of 2025/2026.

What is the length of the mobility?

The mobility must last **from 2 to 12 months**.

What are the conditions for a successful completion of the mobility?

A minimum of 20 credits per semester must be obtained during long-term mobility for the purpose of study (this obligation does not apply to PhD students).

Will the credits be recognized upon my return?

Yes, all earned credits will be recognized. Upon your return, you will need to apply for credit recognition according to faculty procedures.

Is the mobility covered financially?

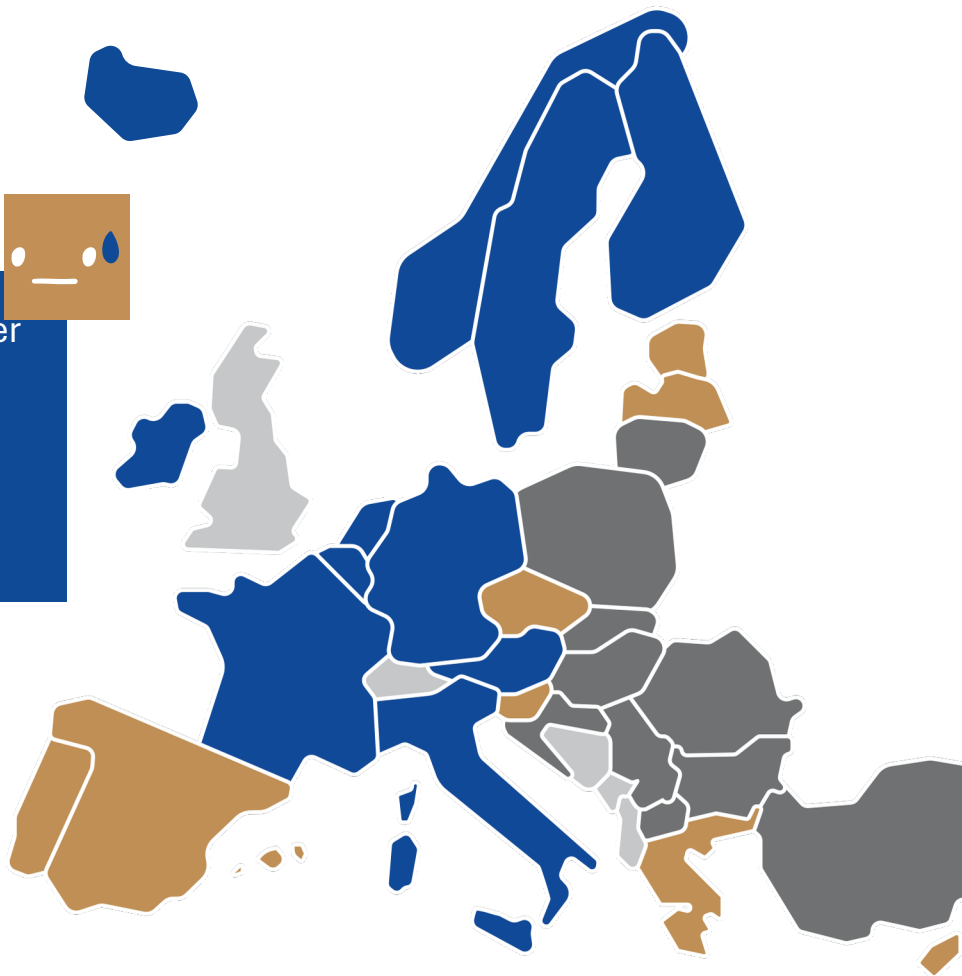
Yes, the entire duration of the mobility is funded without restrictions. The amount of the grant depends on the destination country. In addition, you will receive a **travel grant** (more information on page 15).

Students with fewer opportunities may receive an additional contribution of **€250 per month** on top of the standard grant.



Study mobilities are not available to graduates.

The Erasmus grant helps cover your stay abroad, but it might not cover everything—so it's smart to have some extra savings on hand.

BLENDED INTENSIVE PROGRAMMES (BIP)

Who can participate in the mobility?

BIP is open to all duly enrolled students, full-time and part-time, from 1st year onwards, who have been nominated by their faculty. The target group is determined by the BIP organizers.

What is the implementation period?

BIP must be implemented until 31.7.2026.

What is the duration of a BIP?

BIP consists of a mandatory virtual element and a physical mobility, which can last from 5 to 30 days. The length of the mobility is set by the BIP organiser.

Where can I participate in a BIP?

UPJŠ must have a valid inter-institutional agreement with the organizer of the BIP for the specific programme.

What conditions must be fulfilled for a successful completion of a BIP?

During a BIP, you need to earn **at least 3 credits**. The credits will be fully recognized upon your return, according to the procedures of each faculty.

Are BIPs financially covered?

Yes, **the full duration of the physical mobility is funded**, including travel days, regardless of the destination country. The grant is **€79 per day** (for the first 14 days). You're also entitled to a **travel grant** (see pg. 15).


Students with fewer opportunities may receive a one-time additional contribution of **€100**.



SHORT-TERM PHD MOBILITY

Who can participate in the mobility?

The mobility is available to both full-time and part-time PhD students.



During the mobility, you're not required to earn credits. If you do earn any, they will be fully recognized according to the procedures of each faculty.

What is the implementation period?

The mobility must be implemented until 31.7.2026.

What is the duration of the mobility?

The mobility duration must last **from 5 to 30 days**.

Is the mobility covered financially?

Yes, a **maximum of 10 days of activity and 2 travel days** are funded at a grant rate of **€79 per day**.

In addition, you are entitled to a **travel grant** (see pg. 15).

Students with fewer opportunities may receive a one-time additional contribution of **€100**.

SHORT-TERM BLENDED MOBILITY

1ST & 2ND STUDY CYCLES

Who can participate in the mobility?

Mobility is available to **doctoral** (MUDr./MDDr.), **bachelor** (Bc.) and **master degree students** (Mgr.).

What is the implementation period?

The mobility must be implemented by 31.7.2026.

What is the duration of the mobility?

The mobility must last **from 5 to 30 days**.

What are the conditions for a successful completion of the mobility?

The mobility must include a **mandatory virtual component**, and you need to earn **at least 3 credits**.

The earned credits will be fully recognized according to the procedures of each faculty.

Is the mobility covered financially?

Yes, a **maximum of 5 days of activity and 2 travel days** are funded at a grant rate of **€79 per day**.

In addition, you are entitled to a **travel grant** (see pg. 15).

Students with fewer opportunities may receive a one-time additional contribution of **€100**.

TRAINEESHIP



A traineeship involves the participation of a mobility student in an organization located in an Erasmus+ programme country.

You can do your traineeship:

- in **public** or **private companies** and organizations operating in the labor market, or in the fields of education, vocational training, research, and innovation—regardless of their size,
- at **higher education institutions** with an ECHE charter, or at **embassies**.

Apart from professional ones, you can also take part in **digital skills improvement** traineeships.



LONG-TERM MOBILITY

Who can participate in the mobility?

All duly enrolled full-time and part-time students from their 1st year of study can participate. The mobility is also available to recent graduates.

What is the implementation period?

The mobility must be implemented by 30.6.2026.

What is the duration of the mobility?

The mobility must last **from 2 to 12 months**.

What are the requirements for the traineeship?

The internship must be full-time in the host country.

I'm a graduate—how do I apply for a traineeship?

You must take part in the selection process during your final year of study, and the traineeship must be completed within 12 months after graduation (i.e. after your final exams).



Long-term traineeship mobility is also available for recent graduates.

Can I earn credits for the traineeship?

Yes, you can earn credits for an internship that is part of your study program or a voluntary internship. You need to apply for credit recognition after returning, following the procedures of your faculty.

If you don't receive credits at the faculty level, let us know, and after your mobility ends, we will award you **3 credits for the Erasmus+ traineeship** at the university level.

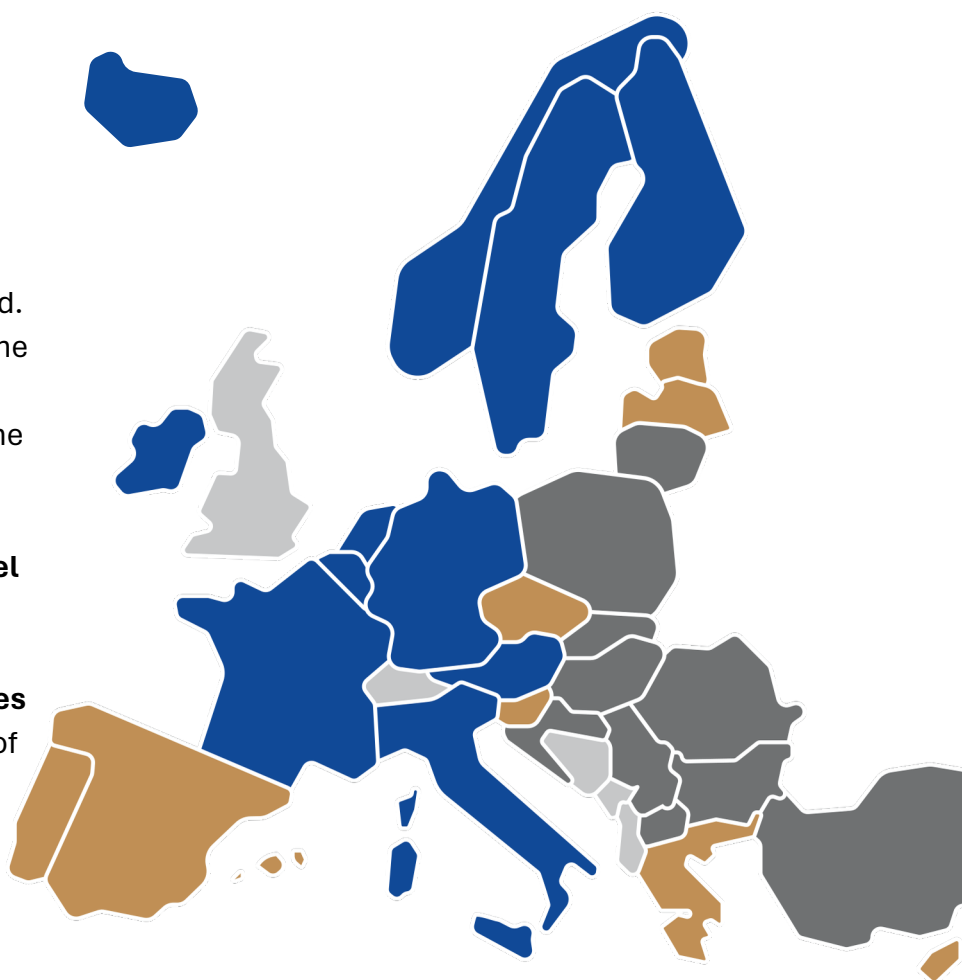
Graduates do not receive credits, as they no longer have student status.

Is the mobility covered financially?

Yes, for students, the entire duration of the internship is funded. For **graduate traineeships**, only the first **2 months** are funded. The amount of the grant depends on the destination country.

In addition, you will receive a **travel grant** (see page 15).

Students with fewer opportunities may receive an additional top-up of **€250 per month** on top of the regular grant.

SHORT-TERM PHD MOBILITY

Who can participate in the mobility?

SHORT-TERM BLENDED MOBILITY

1ST & 2ND STUDY CYCLE

Who can participate in the mobility?

Mobility is available to **doctoral** (MUDr./MDDr.), **bachelor** (Bc.) and **master degree students** (Mgr.).

What is the implementation period?

The mobility must be implemented by 31.7.2026.

What is the duration of the mobility?

The mobility must last **from 5 to 30 days**.

What are the conditions for a successful completion of the mobility?

The mobility must include a **mandatory virtual component**, and you need to earn **at least 3 credits**.

Who is eligible for the travel grant?

Participants of all types of mobility (long-term, short-term, for study or traineeship) are eligible for the travel grant.

Green travel includes: **train, bus, bicycle, and carpooling**, or a combination of these.

Taking a bus to the airport is not considered green travel.

RULES AND FUNDING

OF SHORT-TERM PHD MOBILITIES

(Mobility can be carried out for the purpose of study or internship.)

For the period from 01 August 2025 to 31 July 2026, the university will allocate funding **for 2 mobilities per PhD study program**, which can be carried out either as a study stay or an internship.

Each short-term mobility must meet the non-negotiable minimum duration requirement of at least 5 days.

The university will provide a grant for short-term mobility **covering a maximum of 10 days** of physical mobility abroad.

Under this call, a PhD student may carry out **one mobility** funded by Erasmus+ with a duration of 5 to 10 days.

Participants have the option to carry out mobilities that last longer than the period covered by financial support. These are mobilities with a so-called **combined grant**—i.e. partially funded by Erasmus+ and partially as a zero-grant period—or mobilities that are entirely zero-grant.

One travel day before the first day of the activity abroad and/or one travel day after the last day of the activity abroad is added to the mobility period. These days are included in the calculation of individual support according to the scheme of **5 to 10 days of activity + 2 travel days**.

RULES AND FUNDING

OF SHORT-TERM BLENDED MOBILITIES FOR 1ST AND 2ND STUDY CYCLES

(Mobility can be carried out for the purpose of study or internship.)

Short-term blended mobility (hereinafter STM) consists of a **short-term physical mobility** abroad (in a programme country) **with a minimum duration of 5 days, and a mandatory virtual component**. The volume, format, and timing of the virtual part are flexible and can be freely adjustable.

The virtual component is organized by the sending faculty/department/institute in cooperation with the host institution. The sending faculty/department/institute is responsible for the quality of the implemented virtual activity.

STM is intended for individuals who cannot participate in long-term mobility, for example, due to their field of study or lack of opportunities to participate.

Physical mobility must meet the **essential duration criterion: from 5 to 30 days** (excluding travel time) and **must be combined with a mandatory virtual component**.

The faculty/institute/department is responsible for the appropriate selection of the type of mobility and ensures that long-term mobilities remain the standard.

Participants will be provided with a **grant covering a maximum of 5 days of physical mobility abroad**.

Physical mobility may last longer than the period covered by financial support. These are mobilities with a so-called **combined grant**, i.e. with financial support from Erasmus+ sources combined with a zero-grant period, or mobilities with no grant at all.

One travel day before the first day of activity abroad and/or one travel day following the last day of activity abroad is added to the mobility period. These days are included in the calculation of individual support according to the scheme: **5 days of activity + 2 travel days**.
