LONG-TERM MOBILITY

Who can participate in the mobility?

All duly enrolled full-time and part-time students from their 1st year of study can participate.

Where can I travel to?

You can travel to our **partner institutions**. The list is available here:

When will the mobility take place?

The mobility will take place in the second semester of 2024/2025.

What is the length of the mobility?

The mobility must last **from 2 to 12 months**.

What is the total time I can spend at mobilities?

You can spend **12 months per a study cycle** (24 months in case of long cycle studies).

All types of physical mobilities, including graduate traineeships, count towards the total number of months.

What conditions must be fulfilled?

A minimum of 20 credits per semester must be obtained during long-term mobility for the purpose of study (this obligation does not apply to PhD students).

Will the credits be recognized upon my return?

Yes, all earned credits will be recognized. Upon your return, you will need to apply for credit recognition according to faculty procedures.

Is this type available to recent graduates?

No.

The amount represents an allowance for travel **to and from the place of activity**.

Green travel refers to the following modes of transport: bicycle, bus, carpooling and train. Green travel allowance is eligible if the mobility participant has used a sustainable mode of transport for the majority of the journey.

BLENDED INTENSIVE PROGRAMME (BIP)

Can I participate in BIP?

BIP is open to all duly enrolled students, full-time and part-time, from 1st year onwards, who have been **nominated by their faculty**. The target group is determined by the BIP organizers.

What is the implementation period?

BIP must be implemented until 31.7.2025.

Where can I travel to within BIP?

It is only possible to travel to a university with an Erasmus charter, or to the place where a specific ZIP is organised. UPJŠ must have an inter-institutional agreement with the BIP organiser for the specific BIP.

What is the duration of a BIP?

BIP consists of a mandatory virtual element and physical mobility, which can last from 5 to 30 days. The length of the mobility is set by the BIP organiser.

What is the total time I can spend at mobilities?

You can spend **12 months per a study cycle** (24 months in case of long cycle studies).

All types of physical mobilities, including graduate traineeships, count towards the total number of months.

What conditions must be fulfilled?

You need to earn **at least 3 credits** from the BIP.

Will the credits be recognized upon my return?

Yes, all earned credits will be recognized. Upon your return, you will need to apply for credit recognition according to faculty procedures.

- For the period of 01.08.2024 – 31.07.2025, the university will allocate funds for **1 mobility per each PhD study programme**, which can be implemented either as a study or as a traineeship.
- Every short-term mobility must meet the criterion of minimal duration (min. 5 days).
- The university will provide a grant to the participant of a short-term mobility up to a **maximum amount covering 10 days of physical mobility abroad**.
- Short-term mobility participants have the opportunity to implement mobilities whose duration is longer than the allocated financial support. In this case the so called **combined grant** is applied, i.e. with financial support from Erasmus+ resources combined with a period with zero grant.
- One travel day before the first day of activity abroad and/or one travel day following the last day of activity abroad is added to the mobility period. These days are included in the calculation of individual support according to the scheme of **5 to 10 days of activity + 2 days of travel**.
- PhD students can implement **one mobility** with a duration of 5-10 days in the current Erasmus+ call period.

Rules and funding

- A short-term blended mobility consists of a **short-term physical mobility** (study or traineeship) of students abroad (in a programme country) **with a min. duration of 5 days and of a mandatory virtual element**, while the volume, method and time of realization of the virtual part are freely adjustable.
- The implementation of the virtual element will be **ensured by the sending faculty/department/institute in cooperation with the receiving institution**. The sending faculty/department/institute is responsible for and confirms the quality of the implemented virtual activity.
- The short-term blended mobility is intended for those students who cannot participate in a long-term physical mobility (study or traineeship), e.g. because of their field of study or because they are from a disadvantaged background.
- It is the role of the faculties and the Rectorate to assess the appropriateness of the student mobility choices and to ensure that long-term physical mobilities remain the norm.
- The physical mobility of any short-term blended mobility must meet the criterion of **minimal duration: from 5 to 30 days** (excluding travel time) **and must be combined with an obligatory virtual element**.
- The university will provide the participant of a short-term blended mobility with a **grant up to the amount covering 5 days of physical mobility abroad**.

- Participants of a short-term blended mobility have the opportunity to implement mobilities, the duration of which is longer than the allocated financial support. In this case the so called **combined grant** is applied, i.e. with financial support from Erasmus+ resources combined with a period with zero grant.
- One travel day before the first day of activity abroad and/or one travel day following the last day of activity abroad is added to the mobility period. These days are included in the calculation of individual support according to **the scheme of 5 days of activity + 2 days of travel**.

Traineeship represents the placement of the mobility participant in an organisation located in an Erasmus+ participating country.

The aim of the traineeship is to acquire skills that increase the graduate's competitiveness on the labour market.

LONG-TERM MOBILITY

Who can participate in the mobility?

All duly enrolled full-time and part-time students from their 1st year of study and recent graduates can participate.

Where the traineeship can be implemented?

- Traineeship can be implemented in public and private **companies** and **organisations** abroad, regardless of their size, operating in the labour market or in the fields of education, training, research and innovation.
- An enterprise includes a **higher education institution** with ECHE or an **embassy**.
- You can also take part in a traineeship **to improve your digital skills**.

What is the implementation period?

The mobility must be implemented by 30.6.2025.

What is the duration of the traineeship?

The duration can range **from 2 to 12 months**.

Are there any conditions?

The traineeship must be akin to full-time employment in the target country.

Are traineeships available to recent graduates?

Yes, the selection process must take place during the final year of studies and the traineeship must be completed within 12 months of graduation (i.e. after final exams).

Can I earn credits during a traineeship?

- Yes, it is possible to earn credits for an traineeship. Credit recognition must be requested upon return according to the procedures of the individual faculties.
- **If you do not get credits** at the faculty level, please, inform us and we will award you with 3 credits for the Erasmus+ placement at university level after the mobility.
- **Graduates do not earn credits** as they do not have student status.

Is the full duration of a traineeship covered financially?

For students, funding is unlimited and the total duration of the traineeship is funded.

For graduate traineeships, only the first two months are funded.

- One travel day before the first day of activity abroad and/or one travel day following the last day of activity abroad is added to the mobility period. These days are included in the calculation of individual support according to the scheme of **5 to 10 days of activity + 2 days of travel**.

- The implementation of the virtual element will be **ensured by the sending faculty/department/institute in cooperation with the receiving institution**. The sending faculty/department/institute is responsible for and confirms the quality of the implemented virtual activity.
- The short-term blended mobility is intended for those students who cannot participate in a long-term physical mobility (study or traineeship), e.g. because of their field of study or because they are from a disadvantaged background.
- It is the role of the faculties and the Rectorate to assess the appropriateness of the student mobility choices and to ensure that long-term physical mobilities remain the norm.
- The physical mobility of any short-term blended mobility must meet the criterion of **minimal duration: from 5 to 30 days** (excluding travel time) **and must be combined with an obligatory virtual element**.
- The university will provide the participant of a short-term blended mobility with a **grant up to the amount covering 5 days of physical mobility abroad**.

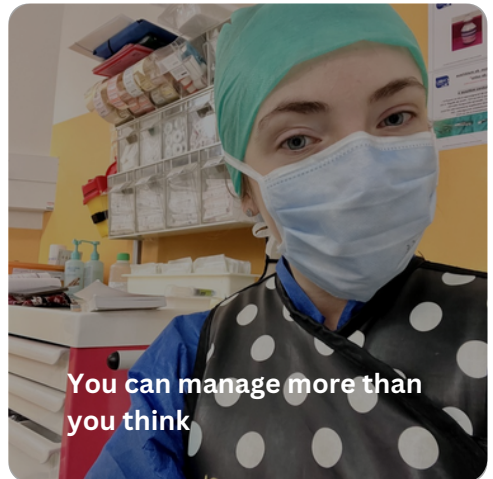
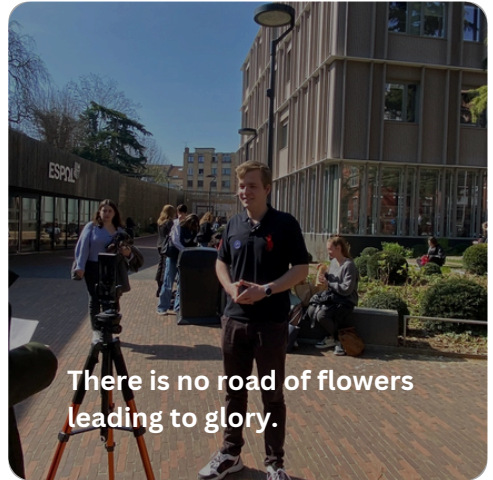
