3.	Fee for the rigorous proceedings and for the defence of rigorous thesis at the Faculty of Arts and Faculty of Science, without recognition of the defended diploma thesis or dissertation thesis as a rigorous thesis	€500.00
4.	Fee for the rigorous proceedings and for the defence of rigorous thesis at the Faculty of Arts and Faculty of Science, with recognition of the defended diploma thesis or dissertation thesis as a rigorous thesis	€250.00
5.	Fee for the rigorous proceedings and for the defence of rigorous thesis at the Faculty of Arts and Faculty of Science, with recognition of the defended diploma thesis or dissertation thesis as a rigorous thesis and with recognition of a successful dissertation examination as a rigorous examination	€0.00
6.	Fee for a retake of the rigorous examination	€100.00
7.	Fee for a retake of the rigorous examination at the Faculty of Arts and the Faculty of Science	€300.00
